- I משנה ד' status of סריסים
 - a מר'י יהושע do they perform חליצה and is it performed on their behalf or not
 - i עריס אדם :oes perform, because he had a moment of כשרות; not so סריס חמה 's solution; כשרות; not so כריס חמה
 - 1 ר' יהושע בן בתירא's testimony supporting ר''צ' approach
 - 2 Difficulty: חייבי equates חייבי לאוין, none of whom perform יבום וחליצה
 - 3 *Answer1*: the שומרת יבם is a הייע) גיורת must hold like יוסי γ קהל גרים ([קהל − ~ קהל גרים | ר' יוסי
 - (a) Note: ר"ע would also allow יבום (as per testimony of ריב"ב), he only said חולץ in response to ר' יהושע
 - 4 Challenge: תוספתא (יבמות יא:ב) tut then divorce because of v. 1 סריס אדם (and others) perform יבום but then divorce because of v. 1 → the issue is ישראלית is a born ישראלית
 - 5 Answer2: he was wounded after נפילתה
 - 6 Challenge: even in such a case, the עשה דייבום (e.g. אחות אשה) trumps the עשה דייבום
 - 7 Answer3: follows version of ר"ע that he only equated לאוין של שאר (e.g. ממזר), not לאוי גרידי (e.g. ממזר), ממזר (שצוע דכא)
 - 8 *Challenge*: he can't fulfill v.2
 - (a) Block: if so, every (most) women are widowed from סריסים, since at their last moment they weren't healthy enough to be מוליד
 - (i) (challenge to משנה in our משנה. having had a "fertile" time isn't good enough)
 - (ii) (answer: the normal infertility at the end of life is just waning power, not סריס
 - ii אר"א's solution: סריס אדם does perform, because he might be healed; not so סריס אדם
 - definition of סריס: he was never fit; as seen by the impotency of his urinal flow
 - (a) cause: his mother baked bread at noon (too hot) and drank strong mead during pregnancy
 - (b) we aren't concerned that he may have healed in the meanwhile, since he started out impotent and is still impotent.
 - (i) Challenge: ruling that we check a מום for the מום of blindness 3 times within first 80 days
 - (ii) Answer: for one organ, we consider that it may have healed; not so the whole body
 - 2 Challenge: מריש ruled that men are considered סרים at 20, women at 18 and they do **not** perform חליצה
 - (a) Answer1: ברייתא changed his mind from that ruling; his final ruling is the one in our ברייתא support)
 - (b) Answer2: that ruling is only in re עונשין: at what age are boys and girls who didn't show סימנין liable
 - (i) Tangential discussion: status of someone who violates law between ages of majority (12/13) and 18 before bringing טימנים and then brings late סימנים:
 - 1. רב retroactive סריס and חייב
 - 2. שמואל was שמואל at that point and פטור
 - challenge (to איילונית: should receive אונס ופתוי even according to איילונית since she is judged retroactively to have been גדולה (see note1)
 - 4. answer: she has no נערות goes straight from בגרות (supporting ברייתא)
 - (ii) אבהו 'ר: we withhold all actions re: סריס ואיילונית (and 8-month baby) until they are 20
 - 1. question: 8-month babies don't live
 - 2. *answer*: if his development was complete →he was a 7-month baby with delayed delivery
 - a. support: רב validated a baby born 12 months after a husband left town delayed
 - b. Support: רשב"ג (in addition to רבי) agrees to principle of delayed delivery

- iii ברייתא signs of שתי שערות] שתי שערות] סימנים (who didn't bring שתי שערות] by age of 20)
 - סריס 1
 - (a) no facial hair
 - (b) soft hair
 - (c) high voice so that it is indistinguishable from a woman's voice (רשב"א)
 - (d) skin is hairless
 - (e) various deficiencies in his urine and/or seminal emission (various תנאים)
 - 2 איילונית:
 - (a) no breasts
 - (b) intercourse is painful
 - (c) male-shaped hips (רשב"ג)
 - (d) deep voice, indistinguishable from man's רשב"א compare his ruling on סריס above)
 - 3 application:
 - (a) if they brought טימנים to be judged thus
 - (b) if they didn't have סימנים:
 - (i) איילונית: must show all deficiencies to be considered סריס/איילונית
 - (ii) ד' יוחנן: any one of the deficiencies establishes status as סריס/איילונית
 - (c) story about ר' נחמן inconclusive, since he had some (faint) beard hair
- II 'סריס ואיילונית: משנה סריס מיילונית: under discussion here is סריס, parallel to סריס איילונית follows איילונית.
 - a סריס (חמה) סריס does not perform יבום וחליצה
 - i If a סריס performed חליצה, doesn't invalidate the woman (doesn't count)
 - ii If a סריס performs ייבום, it invalidates her as a בעילת זנות)
 - 1 Also true if she has ביאה with an outsider (ר' המנונא)
 - a איילונית does not perform יבום וחליצה
 - i if the brothers gave her חליצה, it doesn't invalidate her from כהונה (doesn't count)
 - 1 ~= יהודה who maintains she is invalid for כהונה in any case as she is a זונה
 - ii if the brothers performed ייבום on her, it invalidates her as בעילת זנות
