- I משנה ג': liability for selling wine that goes bad
 - a *If*: someone sells wine and it sours no liability
 - i But: if he was known to sell soured wine מקח טעות
 - 1 א' יוסי בר חנינא. the non-liability is limited to a case where the buyer kept it in his own jugs
 - (a) But: if he kept it in seller's jugs seller is liable
 - (i) Challenge: why did buyer keep it in seller's jugs
 - (ii) Answer: buyer told him that he was buying it for מקפה (must be all good)
 - 1. Question: why does למקפה as buyer's jugs and משנה as buyer's jugs and למקפה
 - a. Why not: seller's jugs w/o מקפה
 - b. Answer: he's bothered by ruling that if seller was known to have wine that sours, מקח טעות
 - c. Question: why doesn't seller ask buyer why he kept it there?
 - i. Answer: he must have said "למקפה"
 - 2 Dissent: ר' חייא בר יוסף wine goes bad as a result of the (current) owner as per v. 1
 - (a) Aggadic tangent: consequences of haughtiness as per vv. 1-2
 - b If: he said "יין מבושם" it must be able to last until שבועות
 - c If: he said ישן must be (at least) from the previous year
 - d If: he said מיושן must be (at least) from two years prior and last until סוכות of the third year (3 full years)
- II Rulings of רבא
 - a If: someone sells wine to a storekeeper for disbursement to purchasers and some goes bad he must recompense
 - Unless: the storekeeper put in new tap (may have caused it)
 - ii And unless: the storekeeper waited until after market day to sell (delay may have caused souring)
 - b If: someone bought wine to have it delivered to a port (e.g.) for sale and while being brought there it depreciated
 - *Then*: the owners absorb the loss
 - ii Question: what if it went sour in the meantime
 - 1 Some say: carrier has responsibility (as per ר' יוסי בר חנינא)
 - 2 Others say: same rule as above, as per ר' חייא בר יוסף
